# WARD WALK

A walk organised by Matthew Curtis, Community Development Officer, LBH took place on 26 September with local Councillors, Officers from LBH & Hounslow Highways and residents in attendance.

The purpose of the walk was to:

- (1) seek remedies to problems associated with the underpass from Osterley Station
- (2) discuss opportunities to improve the area in Spencer Road known as The Green
- (**3**) identify sites for tree planting.

**1.** Whilst the removal of graffiti is promptly achieved it is not a long term solution. Suggestions ranging from the commissioning of panels depicting scenes with local association, 'wrapping' the surfaces and/or engaging with local graffiti artists were discussed

Rough sleepers have been removed following referral to support services and cleansing undertaken.

**2.** Hounslow Highways have agreed to fund the cost and installation of bird and bat boxes together with purchase of bulbs (to be planted by residents).

3. Two more trees will be planted along Spencer Road between lampposts L/012 and L/013.

We are particularly keen to identify further sites for trees in the area perhaps were trees have been lost in the past and empty tree pits remain.

# Stop and Shop Parking at Thornbury Road

The free 30 minutes Stop and Shop scheme was designed to encourage more shoppers to visit local shopping parades by providing 30 minutes free parking.

The council decided to transition to cashless parking in 2016 requiring all parking, including *free* parking sessions, should to be booked or paid for using the *Pay by Phone* service.

It is appreciated that some residents do not have a mobile phone or are unable to use the Pay by Phone digital application to register vehicles for the free parking session.

In advance of a permanent solution residents using the parade are advised to add their vehicle to an *exemptions list*, so that their use of the 30 minute free parking session, is covered.

To join the exemption list call 0208 290 8301 (option 7).

You will need to supply your vehicle registration number and contact details. The vehicle details will be added to an electronic exemption list for approximately three months, this will allow parking at locations where 30 minute free parking is offered.

Unless a permanent remedy is in place by the end date of this interim solution, the exemption scheme will be automatically extended for another three months.

Customers must still adhere to the parking restrictions in place, for example the *no return* period. If people want to park for longer than 30 minutes, they must pay for their parking session using Pay by Phone facilities.



Civil enforcement officers will continue to patrol the area and undertake enforcement as necessary.
